1. The Government of Nepal [GoN] *has allocated funds* towards the cost of **Ghintar-Devghat-Deupur Road Upgrading Works** at Devghat Rural Municipality, Tanahun and intends to apply part of the funds to cover eligible payments under the Contract for **Ghintar-Devghat-Deupur Road Upgrading Works** at Devghat Rural Municipality, Tanahun Contract Identification No: NCB/DRM/ROAD/CN1/2079/080. Bidding is open to all eligible as per Section V of bidding document.
2. Devghat Rural Municipality, Office of Rural Municipal Executive, Devghat, Tanahun invites only electronic bids from eligible bidders for the **Ghintar-Devghat-Deupur Road Upgrading Works** at Devghat Rural Municipality, Tanahun under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.  
Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 47,100,000 (Four Crore Seventy one Lakhs Rupee Only)**
  - Minimum Work experience of similar size and nature: At least one road project with project cost not less than **17,200,000.00** within the last ten years that has been successfully or is substantially completed and that is similar to proposed works with Bituminous /Asphalt Concrete.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously (i) the Technical Bid and the (ii) the Price Bid through e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Devghat Rural Municipality, Office of Rural Municipal Executive, Devghat, Tanahun may visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
5. Bidder shall submit their bid electronically. Bidders may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document amounting NRS 5,000 ( Five thousands Rupee Only) in the internal revenue account of the rural municipality as specified below .

7. Electronic bids must be submitted to Devghat Rural Municipality, Office of Rural Municipal Executive through PPMO's e-GP system [www.bolpatra.gov.np/egg](http://www.bolpatra.gov.np/egg) on or before **12:00Hrs on November 21, 2022**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 Hrs on November 21, 2022** at the office of Devghat Rural Municipality, Office of Rural Municipal Executive, Devghat, Tanahun. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs **11,80,000.00 (Eleven Lakh Eighty thousands Rupee only)**, which shall be valid for 30 days beyond the validity period of the bid (*i.e. March.20,2023*). The scanned copy of bid security should be uploaded in the e-GP system during the bid submission.


